**2005 Environment:** Resolved: The United States Federal Government should substantially change its environmental laws on business and/or industry to improve the environment.

**2006 Foreign Aid:** Resolved, The United States Federal Government should substantially reform its policy for official development assistance to one or more of the following: Argentina, Columbia, or Venezuela.

**2007 Immigration:** Resolved, The United States Federal Government should substantially reform its policy toward illegal aliens residing in the US.

**2008 Campaign Finance:** Resolved, The United States Federal Government should substantially reform its policy toward the financing of federal election campaigns

**2009 Energy:** Resolved, The United States Federal Government should substantially reform its policy towards domestic energy production.

**2010 Income Tax:** Resolved, The United States Federal Government should substantially reform its income tax policy while maintaining total tax revenue at fiscal year 2008 levels.

**2011 International Trade:** Resolved, The United States Federal Government should substantially reform its policy toward trade with China and/or India.

**2012 Agriculture:** Resolved, The United States Federal Government should reform its policy towards domestic agricultural production of food.

**2013 Social Security:** Resolved, The United States Federal Government should reform Title II of the Social Security Act as amended.

**2014 Counterterrorism:** Resolved, The United States Federal Government should reform its counterterrorism policy(s) for the domestic surveillance of U.S. citizens.

**2015 Foreign Aid:** Resolved, The United States Federal Government should reform its policy for the sale of conventional arms to one or more of the following: Taiwan, Bahrain, or Egypt.

**2016 Education:** Resolved, The United States Federal Government should reform its policy or policies for student financial aid for post-secondary education.

**2017 Environment:** Resolved, The United States Federal Government should reform its policy or policies for the regulation or direct industrial emissions of greenhouse gas(es) within the United States.

**2018 Immigration:** Resolved, The United States Federal Government should reform its policy for granting lawful permanent residence status to aliens outside of the United States or legally present within the United States.

**2019 Taxes:** Resolved, The United States Federal Government should substantially increase the percentage of total revenue derived from indirect taxation.

**2020 War Powers:** Resolved, The United States Federal Government should reform the War Powers Resolution of 1973 as amended or its policy for the authorization for the use of military force.

**2021 Postal Service:** Resolved, The United States Federal Government should reform the United States Postal Service.

**2022 Housing:** Resolved, The United States Federal Government should reform its policy or policies for financing the purchase of single-family dwellings, excluding policies enacted for COVID-19 pandemic relief.

**2023 Agriculture:** Resolved, The United States Federal Government should reform its domestic policy or policies for the agricultural production of food in one or more of the following: crop subsidies, concentrated animal feeding operations, or production of genetically engineered foods.

**2024 Foreign Alliances:** Resolved, The United States Federal Government should reform its policy for Western Pacific military defense cooperation with one or more of the following: Japan, The Philippines, or Indonesia.

**2025 Election Administration:** "Resolved, The United States Federal Government should reform its policy for the administration of federal elections."

**2026 Retirement Income:** "Resolved, The United States Federal Government should reform its policy or policies for retirement income."
